Regular Meeting

The Regular Meeting of the Borough of Buena Housing Authority was called to order by Chairperson Giovinazzi on Thursday, February 25th, 2021 at 4:01 pm via tele-conference hosted by Jacqueline Jones, Executive Director, from the Management Offices of the BHA, located at 191 W. The Replacement for Reserve Account maintains a \$188,884 balance at 1/31/2021.

Budget for the Year-Ending 3/31/2022

Ms. Jones stated the Budget for the Year Beginning April 1, 2021, and ending March 31, 2022, has been approved by the State.

Ms. Jones also said a Resolution is on the Agenda for the final Adoption of the Budget.
