# **Regular Meeting**

January 26, 2023 at 3:00pm

The Regular Meeting of the Borough of Buena Housing Authority was called to order by Chairperson Giovinazzi on Thursday, January 26, 2023at 3:00 pm in person at 600 Central Avenue, Minotola, NJ 08341. The meeting was held in compliance with the Open Public Meetings Act and notice of the meeting was provided to the Daily Journal and The Press of Atlantic City.

Two new Commissioners, Elizabeth Testa and Jeannine Bassetti, had been appointed and sworn in by the Borough of Buena Council. Everyone introduced themselves to Betty and Jeannine and welcomed them. They each gave a brief introduction about themselves.

Chairperson Giovinazzi read the "Sunshine Law Statement"

The Replacement for Reserve Account maintains a \$277,240 balance at 12/31/2022.

#### Audit for Year-Ending 3/31/2022

The audit for the year-ending 3/31/2022 is almost complete. This report has been delayed as the auditors have been waiting for the post-employment benefit figures from the State to complete the report.

As of the writing of this board report, the audit remains in review at the audit firm. The report will be forwarded to the board as soon as it is available. The auditor will attend the board meeting to present the audit report to the board. Hopefully, by the March Meeting.

## **Budget for Fiscal Year Beginning 4/01/2023**

Ms. Jones stated the Budget for the Year Beginning April 1, 2023, and ending March 31, 2024, is included in her report for board review.
